# **Privacy Policy**

# What Personal Information About Customers Does Jefferson Financial gather?

The information we learn from customers helps us personalize and continually improve your shopping experience at <u>goldnewsletter.com</u> and <u>neworleansconference.com</u>. Here are the types of information we gather:

## Information You Give Us:

We receive and store any information you enter on our website or give us in any other way. You can choose not to provide certain information, but then you might not be able to take advantage of many of our features. We use the information that you provide for such purposes as responding to your requests, customizing future shopping for you and communicating with you.

## **Automatic Information:**

We receive and store certain types of information whenever you interact with us. For example, like many Websites, we use "cookies," and we obtain certain types of information when your Web browser accesses <u>goldnewsletter.com</u> and <u>neworleansconference.com</u>. A number of companies offer utilities designed to help you visit Websites anonymously. Although we will not be able to provide you with a personalized experience at <u>goldnewsletter.com</u> and <u>neworleansconference.com</u> if we cannot recognize you, we want you to be aware that these tools exist.

# E-mail Communications:

We compare our customer list to lists received from other companies, in an effort to avoid sending unnecessary messages to our customers. If you do not want to receive e-mail or other mail from us, you can easily unsubscribe by clicking the unsubscribe button that is included on each e-mail we send.

## What About Cookies?

Cookies are alphanumeric identifiers that we transfer to your computer's hard drive through your Web browser to enable our systems to recognize your browser. The Help portion of the toolbar on most browsers will tell you how to prevent your browser from accepting new cookies, how to have the browser notify you when you receive a new cookie, or how to disable cookies altogether. However, cookies allow you to take full advantage of some of <u>goldnewsletter.com</u> and <u>neworleansconference.com</u> most interesting features, and we recommend that you leave them turned on.

## **Does Jefferson Financial Share the Information It Receives?**

Information about our customers is an important part of our business, and we are not in the business of selling it to others. We share customer information only as described below and with subsidiaries of Goldnewsletter.com and neworleansconference.com, Inc., who have controls that either are subject to this Privacy Notice or follow practices at least as protective as those described in this Privacy Notice.

## Agents:

We may employ other companies and individuals to perform functions on our behalf. Examples include fulfilling orders, delivering packages, sending postal mail and e-mail, removing repetitive information from customer lists, analyzing data, providing marketing assistance, providing search results and links (including paid listings and links), and processing credit card payments. They have access to personal information needed to perform their functions, but may not use it for other purposes.

#### **Business Transfers:**

As we continue to develop our business, we might sell or buy subsidiaries, or business units. #### How Secure Is Information About Me?

We work to protect the security of your information during transmission by using Secure Sockets Layer (SSL) software, which encrypts information you input. Of course, we transmit the entire credit card number to the appropriate credit card company during order processing. It is important for you to protect against unauthorized access to your password and to your computer. Be sure to sign off when finished using a shared computer.

## Which Information Can I Access?

<u>Goldnewsletter.com</u> and <u>neworleansconference.com</u> give you access to a broad range of information about your account and your interactions, for the limited purpose of viewing and, in certain cases, updating that information.

## What Choices Do I Have?

As discussed above, you can always choose not to provide information, even though it might be needed to make a purchase or to take advantage of such <u>goldnewsletter.com</u> and <u>neworleansconference.com</u> features.

#### Children

<u>Goldnewsletter.com</u> and <u>neworleansconference.com</u> do not sell products for purchase by children. If we sell any children's products, they will be only for purchase by adults. We stand behind the promises we make, however, and will never materially change our policies and practices to make them less protective of customer information collected in the past without the consent of effected customers.

#### **Information You Give Us**

You provide most such information when you search, buy, participate in a contest or questionnaire, or communicate with customer service.
